The Washington Prescription Drug Purchasing Consortium was created by the 2005 legislature to allow self-funded businesses, labor organizations, and local governments in Washington State to pool with the state's purchasing power to get the best prescription drug prices for employees. The WPDP for Groups has over 1,200 participating pharmacies in Washington including most retail chain pharmacies and over 60,000 pharmacies nationwide.

What does this program offer?
